

LEVEL 5 LEADER IN ADULT CARE APPRENTICESHIP

About the apprenticeship

This programme will develop the knowledge, skills and behaviours of leaders in adult care to be proactive and influential, supporting their team to make a positive difference in the lives of the people they support. You will be working in a senior role such as Manager, Deputy Manager or Assistant Manager of an adult care provider or as a personal assistant in a management role to an individual client.

Undertaking this apprenticeship will develop the leader's ability to reflect and build on practice through ongoing professional enquiry and action led research. They will also be supported to learn how to develop and implement a values-based culture.

The leader in adult care will promote the health and wellbeing of all vulnerable adults, whilst ensuring compliance with legislation, regulations, policies and standards at national, local and setting based level. They will be an active leader of the team, ensuring training and values of staff meet legislative and regulatory requirements, as well as potentially being responsible for a range of tasks such as managing risk, organisational change, finance, continuity and business development.

The leader in adult care will develop their skills to inspire their team, to develop the service and ensure it is safe, effective, caring, well led and responsive to the needs of the people they support.

Duration

With a duration of 24 months (including 3 months End Point Assessment), you will receive online and face to face training and support from our assessor.

On starting you will undertake an online skills scan enabling us to understand your learning style and needs and we will tailor your learning experience accordingly. Your assessor will work with you to ensure that you stay on track to complete your programme on time by managing your progress through Bud our learning platform.

Off the Job-Training

Around 6 hours of your working week is spent in completing off the job training. This can be any time devoted to learning and improving new skills and can include:

Online teaching, practical training, writing assignments.

Entry requirements

You will need to be at least 19 years of age and it is recommended that you hold a level 3 qualification or above in a related area.

You must have been a UK, EEA, or EU resident for at least the three years immediately before starting the apprenticeship. In addition, you must be employed in a relevant job role and able to commit to the full length of the programme including the End Point Assessment.

If you do not have GCSE grade C/4 or equivalent in Maths and English, you will be required to work towards achieving these qualifications as part of your apprenticeship.

End Point Assessment

The knowledge, skills, and behaviours that you have learned throughout your apprenticeship, and which confirms that you are occupationally competent will be assessed by an independent assessor. This will be through a combination of the following:-

Observation with Questions, Professional Discussion.

The cost of the programme is £7000 and is funded by the Government. Employers are required to make a co-investment payment of 5% (£350) towards this cost where they employ 50 or more people or employ an Apprentice aged 19 or over.
